

Pellet survivor Insha gets gas agency funds after 8 years

Srinagar: J&K govt approved Thursday Rs 41.2 lakh for a gas agency promised to pellet survivor Insha Mushtaq eight years ago, reviving a rehabilitation pledge that had remained frozen since the fall of the PDP-BJP govt in 2018.

The approval marks a turning point for Insha from Sedow village of Shopian, who lost her eyesight at 14 after a pellet gun struck her on July 12, 2016, during protests following Hizbul Mujahideen commander Burhan Wani's killing.

"Justice delayed but not denied," minister for food, civil supplies and consumer affairs Satish Sharma posted on X after the approval.

The gas agency was announced by then chief minister Mehbooba Mufti after meeting Insha during her treatment.

Doctors said pellets ruptured her right eye, badly damaged her left eye and fractured her nasal, frontal and maxillary bones. Surgeries at AIIMS in New Delhi repaired her facial wounds. She was later shifted to Aditya Jyoti Eye Hospital in Mumbai, but her eyesight couldn't be restored.

Despite the setback, Insha rebuilt her life. She learnt Braille, mobility skills and computer applications. She is now pursuing a bachelor's degree through Ignou.

Assam flood toll rises to 80, over 2 lakh affected

Guwahati: Assam's flood toll spiked to 80 Thursday after two more bodies were found even as IMD predicted heavy rain till next week, potentially complicating the state's efforts to restore normalcy.

The alert came as the BJP-governed state sought a package for four worst-hit districts and urged Centre to recognise this year's deluge as an "atypical, high-intensity, rapid-onset event".

The two bodies were recovered in Sivasagar, among the worst-hit areas besides Charaideo, Jorhat and Golaghat. Over 2 lakh people remain affected overall.

IMD has forecast rain and thunderstorms in Assam and Meghalaya till Aug 4 and Arunachal Pradesh till Aug 2. Similar conditions are likely in Nagaland, Manipur, Mizoram and Tripura till Aug 5.

Assam's demands for a central package were placed before an inter-ministerial team that concluded a four-day assessment of four districts.

CM Himanta Biswa Sarma said an inter-ministerial central team visited the worst affected districts of Upper Assam to undertake an on-ground assessment and review the ongoing relief, restoration and rehabilitation efforts. "The team was apprised of the extensive damage to infrastructure, agriculture and livelihoods," he posted on X.

Ex-civil surgeon held in feticide case in Maha

A doctor (70) — a former civil surgeon & health official — has been booked by Kolhapur police for allegedly carrying out illegal abortions of fetuses. Cops said nearly 300 abortions may have been performed at his hospital. Sleuths are scrutinising records and seized material to ascertain the operation's scale. The doctor was detained following a police raid but was admitted to a hospital after complaining of chest pain. Cops said he would be arrested custody once doctors certify him fit.

Release 3.5k cusecs of water to TN: Cauvery authority to Karnataka

New Delhi: Upholding the Cauvery Water Regulation Committee's order, Cauvery Water Management Authority on Thursday directed Karnataka to release 3,500 cusecs of Cauvery water daily to Tamil Nadu for the next 15 days. As per the direction, Karnataka will have to release a total of 4 TMC (thousand million cubic) feet of river water to the neighbouring state.

The decision came after an emergency meeting convened by the authority to consider Karnataka's appeal against the committee's Wednesday order. The meeting was called as Karnataka appealed to the authority against the order, taking the plea that 'below normal' monsoon rainfall had depleted reservoir levels and that drought conditions prevailed in the state.

State officials are learnt to

have told the authority that Cauvery basin reservoirs in Karnataka currently held around 36.7 TMC of water, which was substantially lower than the 99 TMC recorded during corresponding period last year. They pleaded that it would be difficult to even meet drinking water requirements and other essential needs in the present situation.

INTERSTATE DISPUTE

Tamil Nadu's representatives, however, opposed Karnataka's plea, arguing that the committee's recommendation dealt with only the minimum quantity that should be released. They pointed out that the reservoirs had enough flow and alleged that Karnataka had failed to properly implement the distress-sharing formula prescribed in the situation of deficient rainfall in a particular year.
